4/20/11 King County Fire Chief's: Chief Doerflinger reported that the subjects discussed were fire marshal services, including inspections in the portions of unincorporated King County. Woodinville and Bellevue are starting the Pilot program in June for the county inspections. It is expected that this District will start the inspections at the beginning of 2012. The BLS fee for transport was also discussed. A meeting will be scheduled in May with King County EMS, to continue discussion with the Fire Chiefs that are currently providing BLS Transport.
