## **Correspondence:**

<u>Civil Service Conference by Foster Pepper Shefelman:</u> Chief Doerflinger provided this information to the Board Members.

<u>Letter of Appreciation:</u> Chief Doerflinger read the letter of appreciation commending Firefighters Erickson and Hammock for their professional "world class" performance on a recent incident.

<u>2011 Commissioner Conference- Spokane:</u> Chief Doerflinger inquired as to whether the Board Members were interested in attending. Following discussion, it was decided that Chief Doerflinger may attend this conference in October.

- Commissioner Performance Review: Chief Doerflinger reminded the Board that the evaluations must be completed by September 8<sup>th</sup>.
- ➤ Washington Coalition for Open Government 9/23/11: Commissioner Rydberg stated that she had received information regarding this upcoming one day conference in Seattle and was interested in attending. Following discussion regarding the responsibility of public records and the curriculum of the conference, it was decided that Commissioner Rydberg would attend this conference.
- Commissioner Election (PDC): Commissioner Rydberg stated that she had been in contact with the Public Disclosure Commission to clarify whether there had been a PDC violation during the pamphlet distribution at the Maple Valley Fire Open House. Commissioner Rydberg was assured by Jennifer Hansen, at the PDC, that this fell within her first amendment rights and there had not been any violation. Commissioner Rydberg further stated that she was happy that the concern was brought to her attention, which allowed her to handle it quickly and avoid any issues.
- ➤ Chief Evaluation: Chief Doerflinger distributed an example Chief Evaluation for the Boards review. Following discussion of the scope of this evaluation, it was determined that the district is on schedule to conduct another employee survey the end of 2012, which is 3 years from the last one completed. The commissioners will review the evaluation form and provide input. The Chief will add a paragraph of intent.

Commissioner Scott excused himself for a ten minute break.

#### Personnel:

Career/Volunteer Staff: Deputy Chief Cowan reported that all firefighters are back on regular duty.

## **Operations:**

Major Emergency Incident Report: Deputy Chief Cowan reported that there was a CPR today at the gun range.

Training: Deputy Chief Cowan reported that blue card training, MCI and suppression drills are ongoing and the intruder drill is scheduled for September 28<sup>th</sup> at 7:00 am.

## **Support Services:**

Fire Marshal: Deputy Chief Cowan reported that there are vacant apartments in Maple Valley that are being occupied by squatters. The crews are familiar with the location and situation.

Fred Meyer continues to work on the water retention but is being held up by TRM's construction. Commissioner McGee inquired about retention pond codes.

8/20/11 Maple Valley Fire & Life Safety Open House: Chief Doerflinger reported that this event was a success; although the number of attendees was down from the previous year. The department will be looking into changing the date and advertising more next year.

Rotary Club Gala Dinner (not on agenda): The Board of Commissioners discussed the possibility of purchasing a table for this event. Firefighter Fox asked that this information be forwarded to the Union; as they may have interest as well.
