# Meetings:

➤ <u>King County Parks Levy Meeting 4/10/13:</u> Chief Doerflinger reported that he attended this meeting with King County Fire Chief's President Randy Krause. It was agreed that the Parks Levy ordinance would include language that would protect and reimburse Fire Districts, should they be pro-rationed by the Levy. King County Council Member Kathy Lambert will introduce the ordinance for Council approval.

- ➤ <u>King County RPC/EMS Levy 4/10/13:</u> Chief Doerflinger reported that he watched this meeting live and stated that Kirkland Fire and the King County EMS Committee agreed to conduct an ALS Study before 2016, resulting in Kirkland Fire supporting the Regional EMS Levy.
- Officer's Meeting 4/10/13: Deputy Chief O'Brien reported that since the inception of the Training Consortium, the district's training focus has shifted away from District Specific Training and he would like this incorporated into the Officer Meetings on a regular basis. The Officer Meeting on April 10<sup>th</sup> addressed 4 buildings in the district as well as the Taxi Voucher and Safe Rider Programs.
- ➤ <u>LMC 4/11/13</u>: Chief Doerflinger reported that the grievance is at an impasse and Local 3062 would like to have their appeal heard by the Board of Fire Commissioners on at the May 2<sup>nd</sup> meeting. The Board of Fire Commissioners agreed to hear the appeal.
- ➤ <u>Chamber of Commerce 4/17/13</u>: Chief Doerflinger reported that he presented levy information at the Chamber of Commerce.
- ➤ <u>LERA Conference 4/18/13:</u> Commissioners DeBay, Scott and VanRuff attended this Conference with Chief Doerflinger and Deputy Chief O'Brien. Notable information provided was the progressive discipline and district "ability to pay" in arbitration.

#### **Business:**

- Donation Purchase Recommendation: Chief Doerflinger asked for and received concurrence from the Board of Fire Commissioners to purchase 4 or 5 AED's for Staff Vehicles and an Automated Blood Pressure Machine for Station 80 with the recent donation from Joyce Herr.
- AG 43-1129 Performance Management System: Chief Doerflinger reported that AG 43-1129 is now entering the two week review period.
- Maintenance and Operations Levy: Chief Doerflinger reported that Liz Loomis will be at the Board Meeting on May 16<sup>th</sup>. In addition, Chief reported that 8,271 (approximately a 33% turnout) votes are needed to validate the levy and to date 22% are counted.
- Commissioner Meeting Schedule: Chief Doerflinger advised the Board of Commissioners of two possible meeting conflicts. Chief Cowan is being sworn in as Fire Chief of Shoreline on June 6<sup>th</sup> and the first meeting in July conflicts with the 4<sup>th</sup> of July Holiday. It was determined that the June 6<sup>th</sup> meeting would be held at 2:00 pm and the July 4<sup>th</sup> meeting would be cancelled.

Deputy Chief O'Brien reported that there are currently 2 firefighters on short term Labor
 Industries and 1 firefighter on sick leave, which may turn into Long Term Disability.

## **Operations**

- <u>Training:</u> Deputy Chief O'Brien reported that Live Fire Training in North Bend is ongoing.
- <u>Incident Report:</u> Deputy Chief O'Brien stated that to date there have been 700 calls, compared to last year this time at 841. Since the last Commissioner Meeting, there have been 95 calls, 66% of those EMS. Of significance were the double shooting, tender mutual aid with Eastside Fire and a drive by shooting in the Maple Valley Heights area.
