➤ <u>Kent RFA 8/1/13:</u> Chief Doerflinger met with Chief Schneider of Kent Fire to discuss the yearly training consortium contract and possible consolidation of Administration and Information Technology. The consortium contract fee formula has been defined and the cost will be \$34,800 in 2014.

- ➤ <u>LMC 8/13/13:</u> Chief Doerflinger reported that 9 items were reviewed and there were no issues.
- Negotiations 8/14/13: Chief Doerflinger reported that staffing levels are currently being negotiated with Local 3062. A follow-up meeting is scheduled for August 28<sup>th</sup>.

#### **Business:**

- South King County Fire Training Consortium: A MOTION was made, seconded and unanimously carried to authorize Chief Doerflinger to enter into the Training Consortium Interlocal Agreement.
- Future Fire Station Property with Tahoma School District: Chief Doerflinger met with Mike Maryanski regarding future fire station property. Tahoma School District intends to purchase this 35 acre parcel from King County and will continue to work with the District in securing a parcel for a future fire station. At this time, King County Shops will remain in their current location.
- Donation of World Trade Center Steel: Chief Doerflinger reported that Firefighter Ryan Carpenter has secured a 1 ½ ft. piece of steel from the World Trade Center. An article will be written in hopes of soliciting donations for the shipping costs and future memorial to be located in the City of Maple Valley. The piece of steel will be on display in the lobby at Station 80 until a memorial fund and location can be established.
- Resolution R-2013-013 Sole Source Supplier Purchase of Radios: A MOTION was made, seconded and unanimously carried to approve Resolution R-2013-013 Sole Source Supplier Purchase of Radios.
- Fence Station 80: Chief Doerflinger presented the Board of Fire Commissioners with 3 bids for fencing at Station 80. Commissioner DeBay inquired about firefighter privacy with the wood fence being removed, discussion followed. A MOTION was made, seconded and unanimously carried to award the bid to Bergsma Fencing.
- <u>District Visa</u>: Chief Doerflinger asked the Board of Fire Commissioners to consider increasing the limit of the district visa from \$5,000 to \$10,000. A MOTION was made, seconded and unanimously carried to increase the district visa from \$5,000 to \$10,000.
- Leadership Institute of South Puget Sound: Commissioner Scott has just recently completed this course and suggested that the District budget for one chief officer to attend each year. Chief Doerflinger will plan to attend this year.
- Run Review Contract with Jeff Merritt: A MOTION was made, seconded and unanimously carried to approve the personal services contract with Jeff Merritt for 2014 in the amount of \$7,800.

## **Career/Volunteer Staff**

Deputy Chief O'Brien reported that there is currently 1 employee on light duty, 1 employee on Disability and 1 employee on Long Term Disability for up to 9 months. A Volunteer Firefighter meeting was held August 14<sup>th</sup> and was well attended. Commissioner DeBay asked for and received information regarding compensation of live in Volunteers.

# **Operations**

- <u>Training:</u> Deputy Chief O'Brien reported that Lake Wilderness diver training is still underway and the Shooter Drill is scheduled for October 2<sup>nd</sup>.
- <u>Incident Report:</u> Deputy Chief O'Brien reported that ladder rodeo training is in progress. Volunteer Firefighters have been attending the driver/pumper class, which is estimated to be completed by September 1<sup>st</sup>. Call volume is the same as last year this time. E-83 was involved in an accident and is currently Out of Service. The Shooting incident of August 13<sup>th</sup> was reported on.

- Apparatus & Equipment: Deputy Chief O'Brien reported that E-83 is currently Out of Service, we have received interest in the surplus Engine and Aid Car production is still on track.
